<u>1:</u> Enable meaningful involvement of excluded people in the design and implementation of programs aimed to support them.	ARC is carving out spaces for meaningful participation of excluded people in the traditional programs. For example, Preparedness programs like 'Sound the Alarm' include specific funding and activities to ensure inclusion of diverse populations. This year, there is an increased focus on community action vs. Red Cross led programming.
<u>2</u>: Ensure that staff and volunteers reflect the diversity of the societies where they work.	This is one of the priorities for the Community Engagement unit. ARC is reaching out to diverse populations through its various programs to meaningfully engage them and diversify the workforce.
